PART B**1. Definitions & Abbreviations**

In this Policy where the context so admits, the masculine shall include the feminine and the following expressions shall unless repugnant to the context have the following meanings;

- a) **'Act'** means the Insurance Act, 1938 (4 of 1938)
- b) **'Age'** means age of the Member at last birthday
- c) **'Annual Renewal Date'** shall mean the date corresponding numerically with the Policy Commencement Date in each subsequent year, and till the end of the Duration Chosen.
- d) **'Beneficiary/Claimant'** shall mean the person who has been appointed by the Member as the nominee, and whose name has been entered in the Membership Register kept by the Policyholder, as being eligible to receive the benefits payable under the Policy on the death of the Member.
- e) **'Bulk Exits'** shall mean such exits as defined in the Scheme Rules where the total amount on exit due to any event, in a given Policy Year, including the current amount on exit exceeds 25% of the Policy Account Value at the beginning of the Policy Year.
- f) **'Company/We/Us'** shall mean and refer to the Bajaj Allianz Life Insurance Company Limited.
- g) **'Contribution'** shall mean the amount as determined through an independent actuarial valuation by the Policyholder and is payable by the Policyholder to the Company.
- h) **'Contribution Date'** means the date mentioned in the Schedule on which a particular contribution in the Policy was received.
- i) **'Customer Information Sheet (CIS)'** is the document provided to the Policyholder along with the Policy Document that explains the basic features of the Policy in simple words
- j) **'Duration Chosen'** means the tenure of investment that the Policyholder chosen at the time of making a Contribution. The Duration Chosen at the time of making a Contribution cannot be changed subsequently.
- k) **'Endorsement'** means conditions attached/affixed to this Policy incorporating any amendments or modifications agreed to or issued by the Company.
- l) **'Entry Date'** shall mean:
 - i) the Policy Commencement Date, in relation to the Members already existing as Members under the Scheme on the Policy Commencement Date and
 - ii) in relation to a new Member the date when his name has been recorded in the Membership Register as a Member, after due written approval from the Company.
- m) **'Financial Year'** means the year starting from 1st April of a year and ending on 31st March of the next year.
- n) **'Free Look Period'** means the period in which the Policyholder can choose to terminate the Policy as per the details mentioned in Section 10 below.
- o) **'Fund'** means the investment fund created as per Section 11 below to manage the Contribution under Bajaj Allianz Life Group Secure Return plan.
- p) **'Goods and Service Tax (GST)'** is charged based on type of Policy communication address of Policyholder. This may change subject to change in rate/state in address of the Policyholder as on date of adjustment.
- q) **'Guaranteed Interest Rate (GIR)'** shall mean the rate of return applicable to a Contribution based on the Duration Chosen by the Policyholder at the time of making the Contribution. The GIR can be different for each Contribution made in the Policy and is as mentioned in the Schedule or by way of any Endorsement.
- r) **'Grace Period'** means a period of fifteen (15) days for monthly Contribution payment frequency and thirty (30) days for other than monthly Contribution payment of frequency, from the due date of the Contribution payment.
- s) **'IRDAI'** means the Insurance Regulatory and Development Authority of India.
- t) **'Life Cover'** means the cover provided against the risk of death to the Member and shall be deemed to commence on the Date of Commencement of Risk of the Member.
- u) **'Market Value Adjustment Factor'** shall mean the ratio, at any point of time, of the values detailed in Section 4(d)(viii) below. This valuation will be according to the IRDAI (Actuarial, Finance and Investment Functions of Insurers) Regulations, 2024, as applicable and as amended from time to time.
- v) **'Market Value Adjustment (MVA)'** shall mean the difference of the values as detailed in Section 4(e) below. This valuation will be according to the IRDAI (Actuarial, Finance and Investment Functions of Insurers) Regulations, 2024, as applicable and as amended from time to time.
- w) **'Member'** shall mean a person who meets and continues to meet the eligibility criteria specified in the Scheme Rules, and whose name has been recorded in the Membership Register as a Member effective from the Entry Date and on whose life the benefits under this Policy has been effected.

- x) **'Membership Register'** shall mean a record of Members maintained by the Policyholder which contains information about Members including but not limited to any unique identification number of the Member, name, age, gender, Entry Date, Sum Assured (if any), Normal Retirement Date and Beneficiary.
- y) **'Membership Year'** means the year commencing on the Entry Date or an anniversary thereof for a Member
- z) **'Net Contribution'** means the amount of a Contribution net of premium allocation fee [as per Section 12a) below] and any applicable GST & cess.
- aa) **'Nomination'** means the process of appointing person(s) to receive policy proceeds/benefits on the death of the Life Assured (in a Policy where the Life Assured is also the Policyholder). Nomination shall be as per section 39 of the Insurance Act 1938, as amended from time to time.
- bb) **'Nominee'** means the person(s), as mentioned in the Schedule, who has/have been nominated in writing to the Company by the Policyholder, who is entitled to receive the Death Benefits under the Policy.
- cc) **'Normal Retirement Date'** shall mean the date specified in the Membership Register for each Member on which the Member is expected to retire from service.
- dd) **'Policy'** shall mean the arrangements established by the Policy Terms and Conditions.
- ee) **'Policy Anniversary'** means the date corresponding numerically with the Policy Commencement Date in each subsequent year
- ff) **'Policyholder/you/your'** means the name as given in the Schedule, who has concluded the Policy with the Company for the benefit of the Members.
- gg) **'Policy Year'** means the year commencing on the Policy Commencement Date or a Policy Anniversary thereof
- hh) **'Policy Account'** shall mean the single account maintained by the Company under this Policy to manage the Contributions for the Policy.
- ii) **'Policy Account Value'** shall mean the value of the Policy Account on any day.
- jj) **'Policy Commencement Date'** shall mean the date, as specified in the Schedule, from which this Policy was effected.
- kk) **'Policy Document'** shall mean this Policy wording, the Schedule as above, statement of Policy Account (as attached herewith and forms part of this Policy and if revised the latest one) and the Policyholder's statements in the Proposal Form submitted by or on behalf of the Policyholder for the purpose of obtaining this Policy and any other information or documentation provided to the Company for that purpose and based upon which this Policy has been issued.
- ll) **'Policy Term'** means that the Duration Chosen by the Policyholder at the Policy Commencement Date.
- mm) **'Policy Year'** shall mean the year commencing on the Policy Commencement Date or on any Annual Renewal Date.
- nn) **'Revival period'** will be up to the end of the Policy Term of one (1) year
- oo) **'Schedule'** means a document which is attached to and forms a part of this Policy containing specific details of the Policy.
- pp) **'Scheme Rules'** means the rules adopted by the Policyholder and approved by the Company to run the scheme under Bajaj Allianz Life Group Secure Return Plan to provide benefit to the Member, as a pre-requisite to the issuance of this Policy. A certified copy of the Scheme Rules has to be furnished to the Company by the Policyholder.
- qq) **'Sum Assured'** is the amount as specified in the Membership Register w.r.t. a Member which is referred to, to determine the Death Benefit payable to the Nominee after the Date of Commencement of Risk.
- rr) **'Surrender Value'** has the meaning given in Section 4.f) below.
- ss) **'UIN'** means the Unique Identification Number allotted to this Plan by the IRDA
- tt) **'Vesting Benefit'** shall have the meaning as mentioned in Section 4.b) below.
- uu) **'w.r.t.'** means 'with respect to'

PART C

2. Policy Description

- a) Bajaj Allianz Life Group Secure Return plan is a, non-linked, non-participating group life savings product.
- b) On the Policy Commencement Date, the Company shall open a Policy Account for the Policy. All the Contributions received by the Company net of any premium allocation fee, mortality fee (if any) and any applicable GST & cess shall be credited to the Policy Account. All benefits [as mentioned in Section 4 below], except the Sum Assured, will be paid out of the Policy Account
- c) The Policy under the plan will be maintained

at Pooled level.

- d) The GIR will be credited into the Policy Account daily on compounding basis based on the Policy Account Value available then.
- e) Any exit from and Net Contribution to the Policy Account will get GIR only for the period it remained invested in the Policy Account.

3. Contribution

Contributions are payable by the Policyholder (based on an independent actuarial valuation carried out by the Policyholder from time-to-time), without any obligation on the Company to issue a notice for the same.

4. Benefits

(a) On Death of a Member

On the death of a Member, the Death Benefit payable shall be equal to a lump-sum amount as decided by the Policyholder in accordance with the Scheme Rules and will be payable from the Policy Account, plus any Sum Assured w.r.t. that Member.

(b) On Vesting or Retirement of a Member

- i) On vesting or retirement of a Member on his Normal Retirement Date, the Vesting Benefit payable shall be equal to a lump-sum amount as decided by the Policyholder in accordance with the Scheme Rules, and shall be payable from the Policy Account.
- ii) If the superannuation fund of the Policyholder is maintained with other insurers along with this Policy, the Member will have the option to choose the insurer from whom to purchase the immediate annuity.
There shall be an assured benefit of 101% of contribution, net of withdrawals, if any, applicable on the entire pension fund available with the insurer. An assured benefit will also be available on the death of every member, as per the Scheme Rules.

(c) Other Exits/Benefits

On exits such as resignation, termination, etc., as per the Scheme Rules, the benefit payable will be equal to the lump-sum amount as decided by the Policyholder in accordance with the Scheme Rules and will be payable from the Policy Account.

(d) On Bulk Exits

On Bulk Exits in any Policy Year, the benefit payable [as per Section 4(a), Section 4(b) & Section 4(c) above] will be an amount as requested by the Policyholder and the Policy Account will be reduced by the amount requested grossed up for the Market Value Adjustment (if applicable), if such amount does not exceed the Policy Account Value.

However, if such grossed-up value exceeds the Policy Account Value, then, the Policy Account Value less Market Value Adjustment (if applicable) shall be payable. The grossed up amount mentioned above shall be arrived by dividing the amount requested-for by (1 - Market Value Adjustment Factor).

(e) Market Value Adjustment (MVA)

If the total amount due to Exits, as per the Scheme Rules, in a Policy Year due to any event (including the current amount on Exit/s) exceeds the amount of Bulk Exits, Market Value Adjustment shall be applied only to the amount which is over & above the amount representing Bulk Exits. The Market Value Adjustment will be calculated as given below:

- i). The market value of the underlying asset will be ascertained on the date of exit.
- ii). The difference between the Policy Account Value and the market value (both, on the date of exit) will be calculated.
- iii). The Market Value Adjustment is a factor to cover the market value losses of the underlying investment in relation to the balance in the policy account.
- iv). If the above difference is positive, then, the MVA is applicable; else, the MVA shall be zero.
- v). The amount on which MVA is applicable is {Total Amount Withdrawn in a given Policy Year – Amount of Bulk Exits of that Policy Year} = A
- vi). Market value of assets as a proportion of the Policy Account Value = (Market value of assets / Policy Account Value) = B
The market value of assets & the Policy Account Value used here will be based on the values before the current withdrawal.
- vii). $MVA = [(A/B)-A]$

- viii). Gross up value for MVA = MVA + current withdrawal amount requested
- ix). Market Value Adjustment Factor = (MVA / Gross up value for MVA)

(f) Surrender Value on Surrender/ Termination of Policy

- i) The Policyholder may surrender/ terminate the entire Policy by giving at least three (3) months prior written notice to the Company.
- ii) On surrender/termination of the Policy, the Surrender Value payable will be the Policy Account Value as on the date of surrender/termination less the Market Value Adjustment (if applicable). The Surrender Value will be payable to the Policyholder and, on payment of the Surrender Value, the Policy will terminate.
- iii) There is no other charge/fee on surrender/termination except the Market Value Adjustment, as mentioned in Sub-Section ii) above.
- iv) The Company reserves the right to stop enrollment of new Members or terminate the Policy by sending not less than ninety (90) day's advance notice in writing to the Policyholder expiring on the Annual Renewal Date.

PART D

5. Non-forfeiture

- a) Where the Policy Account is sufficient or overfunded/in-surplus as per the independent actuarial valuation certificate submitted by the Policyholder, the Company shall allow nil Contribution, and the Policy Account shall keep on accumulating, at the GIR and the Policy will be continued.
- b) If the Policy Account Value falls below Rs. 55,000, the Company will intimate the Policyholder to make Contribution within one (1) month to keep the Policy Account Value reasonably above Rs. 50,000; else the Policy will be terminated and the Surrender Value as on the date of termination shall be paid to the Policyholder.
- c) Notwithstanding this, if independent actuarial valuation certifies that the policy account/s is/are sufficiently funded, the policy be continued.

If life cover has been opted-for in the Policy:

- a) When the Policy Account has insufficient balance to deduct the mortality fee [as per Section 12c) below] along with applicable GST/Cess in respect of the Policy within the Grace Period, the life cover under the Policy shall cease and no Sum Assured will be payable on death.
- b) The life cover can be revived within the revival period [of five (5) years from the date of first unpaid mortality fee], subject to underwriting (if any)
- c) At the expiry of the revival period, if the life cover has not been reinstated, then no Sum Assured shall be payable on death in the Policy.
- d) Notwithstanding this, if the Policy Account is sufficient to deduct the mortality fee [as per Section 12c) below] along with applicable GST/Cess, the Company will renew the Policy at every monthly due date.
- e) If the Policy Account is not sufficient to deduct the due mortality fees [as per Section 12c) below] along with applicable GST/Cess (but is above Rs. 50,000, as mentioned above), the Company will intimate the Policyholder to make Contribution within one (1) month to keep the balance in the Policy Account reasonably above mortality fee [as per Section 12c) below] along with applicable GST/Cess; else Surrender Value at the time of termination shall be paid, and the Policy will terminate.

6. Renewal of Policy

The Policy will be automatically renewed on each Annual Renewal Date till end of the Policy Term. On the Annual Renewal Date, the Policyholder shall furnish to the Company data of the eligible Members.

7. Flexibilities

a. Policy Continuation Option

At the end of the specified duration in the policy, the Policyholder will have the following options to continue the policy

- i) either by continuing the policy for 1 year by default, or
- ii) choose a new specified duration

Both the above options are subject to availability of the product then.

The GIR applicable for the 1st year or the new specified duration chosen will be as per the declared rates prevailing then.

8. Eligibility

A Member's coverage under this Policy shall commence on the Entry Date subject to he being eligible and continuing to be eligible for the benefits as specified in the Scheme Rules and terms of the policy. Any variations in the Policy Terms and Conditions effected hereunder and in respect of Membership, after the Policy Commencement Date, shall be given effect to only by endorsements and by a signature of a duly Authorized Officer of the Company.

9. Termination of policy

The Policy shall terminate on the occurrence of the first of the following events:

- i) The date on which MPH terminates the Policy
- ii) The date on which the Company terminates the Policy, as per Non-forfeiture Section 5 above
- iii) On Freelook Cancellation
- iv) At the end of specified duration chosen by the MPH, subject to the policy not being continued as per section 7 above.

10. Free Look Period

- 1) The policyholder shall be provided a Free Look Period of 30 days beginning from the date of receipt of Policy Document, whether received electronically or otherwise, to review the terms and conditions of such Policy.
- 2) In the event the policyholder disagrees to any of the Policy terms or conditions, or otherwise and has not made any claim, he shall have the option to return the Policy to the Company for cancellation, stating the reasons for the same.
- 3) Irrespective of the reasons mentioned, The policyholder shall be entitled to a refund of the Contribution paid subject only to a deduction of a proportionate risk premium for the period of cover and the expenses, if any, incurred by the Company on medical examination of the proposer and stamp duty charges.
- 4) A request received by the Company for cancellation of the Policy during Free Look Period shall be processed and Contribution shall be refunded within 7 days of receipt of such request, as stated in Sub-Section (3) above.

11. Maximum Liability of Company

The maximum liability of the Company towards any benefit payable to the Policyholder or any of the Members, at any point of time shall be to the extent of the value of the Policy Account. In case of complete surrender of the Policy, the Company's liability shall be further reduced by any applicable Market Value Adjustment and, in case of Bulk Exits, the Company's liability shall be reduced by any applicable Market Value Adjustment.

PART E**CHARGES, FUND OPTIONS, PORTFOLIO STRATEGIES, Etc****12. Investment of the Fund**

The Company shall create a separate fund for all the Policies issued under Bajaj Allianz Life Group Secure Return and selection of the underlying investments of such fund shall be such as the Company, in its sole and absolute discretion, may from time to time determine, in accordance with IRDAI regulation on controlled fund, and it is further provided that the assets of such fund would comprise in such proportion as that stipulated for the non-linked funds in the IRDAI's rules and regulations on investments, as amended from time to time.

All assets relating to the fund shall remain in the absolute beneficial ownership of the Company. There is no trust created, whether expressly or impliedly, by the Company in respect of the assets or investments.

13. Fees

All the Fees mentioned below will be subject to applicable GST & cess.

a) Premium Allocation Fee

Direct Marketing Channel: Nil

Other than Direct Marketing Channel: Lower of 0.5% of the contribution paid during the year or Rs. 10 lakh

b) Surrender/Termination Fee/Penalty

Nil

c) Mortality Fee

The mortality fee will be Rs. 1 per 1000 SA, per Member. The mortality fee shall be deducted monthly based on the Sum Assured w.r.t. a Member. The mortality fee is guaranteed for the Policy Term and will be applied on the Sum Assured.

15. Mode of payment of Claim and Discharge

A discharge or receipt of the Policyholder or on their behalf of any person or persons duly authorized in writing by the Policyholder shall be a valid and sufficient discharge to the Company in respect of any payment due and paid by the Company. Fraud & Misstatement and forfeiture would be dealt with in accordance with provisions of section 45 of the Insurance Act, 1938, as amended from time to time. This Policy Document constitutes the complete contract of insurance. This Policy Document cannot be changed or varied except by an Endorsement to the Policy, in writing and signed by an officer of the Company authorized for the purpose.

24. Payment of Claim

Upon death of the Member, the payment of Death Benefit will be subject to the Company's right to receive all information and documentation sought which includes but not limited to following:

(a) Claim intimation should be received in writing within 180 days of occurrence of the death. However, the Company may condone

the delay in claim intimation, if any, where the delay is proved to be for reasons beyond the control of the claimant

- (b) Death Certificate issued by the local municipal authority
- (c) Supporting documents as per the option/s as chosen by the Policyholder at inception for disbursement of benefits.
- (d) A discharge or receipt of the Policyholder or on their behalf of any person or persons duly authorized in writing by the Policyholder shall be a valid and sufficient discharge to the Company in respect of any payment due and paid by the Company. The benefit amount shall be sent by the Company to the Policyholder for the benefit of the Beneficiary. Once the Company has made the payment to the Policyholder, the Policyholder is completely responsible to hand over the entire amount paid by the Company to the Beneficiary and the Company shall not have any further liability in respect of such payment.

25. Loss of Policy Document

- a) If the Policy Document is lost or destroyed, then subject to Sub-Section c), at the request of the Policyholder, the Company, if satisfied that the Policy Document has been lost or destroyed, will issue a copy of the Policy Document duly endorsed to show that it is issued following the loss or destruction of the original document. The Company will charge a fee for the issuance of a copy of the Policy Document. Currently, for issuance of duplicate Policy Document, a fee of Rs. 100 plus a Stamp Duty fee (as applicable for the applicable State/Union-Territory) is being charged.
- b) Upon the issue of a copy of the Policy Document, the original Policy Document will cease to have any legal effect.
- c) The Company reserves the right to make such investigations into and call for such evidence of the loss or destruction of the Policy Document at the expense of the Policyholder, as it considers necessary before issuing a copy of the Policy Document.
- d) It is hereby understood and agreed that the Policyholder will protect the Company and hold the Company harmless from and against any claims, costs, expenses, awards or judgments arising out of or howsoever

connected with the original Policy Document or arising out of the issuance of a copy of the Policy Document.

26. Policy Conditions

- a) The Policyholder shall furnish to the Company all such data, information or evidence as the Company may reasonably require from time to time in respect of the coverage of each Member under the Policy and the Company shall not be liable for any action taken in good faith upon any data, information, or evidence so furnished which shall be or shall prove to have been erroneous or inaccurate.
- b) The Policyholder's records in original (or certified photocopies thereof) as in the opinion of the Company have a bearing on the benefits to be provided or the Contribution payable hereunder shall be open for inspection by the Company at all times.
- c) It is expressly agreed between the Policyholder and the Company that this Policy is effected in accordance with the provisions of the Scheme Rules and in the event of the Scheme Rules being amended, such amendments, if they have any bearing on or affect in any way, the Policy Terms and Conditions shall become effective only if the said amendments are approved in writing by the Company on such terms as the Company may stipulate. Any alteration or amendment that may become necessary in the Policy Terms and Conditions on account of any amendment or alteration, approved by the Company in the provisions of the Scheme Rules shall be given effect to by appropriate endorsements to the Policy signed by an authorized officer of the Company. In the event of the Scheme Rules being amended by the Policyholder and such amendments, if they have any bearing on or affect in any way, the Policy Terms and Conditions and is not acceptable to the Company then the Policy shall be terminated and benefit payable as per Section 4(f) above.
- d) The Company reserves the right to recover the amount from the Policyholder or the Member or any other person, if it is found that the Benefits are erroneously paid due to the fault of the Policyholder. In case we are not in a position to recover such amounts from the Member or any other person, the

Policyholder will be liable to pay the said amount to the Company within 15 days from the date of its demand. However, the Policyholder will not be liable or responsible for any wrong payments made by the Company without any fault on the part of the Policyholder.

- e) The Membership Register as per the annexure to proposal form has to be updated by the Policyholder for all additions and deletions and send the Company the updated data through CD or hard copy for updating the Company's records.

27. Governing Law

Any and all disputes arising out of and under this Policy shall be governed by and determined in accordance with Indian law and by the Indian Courts.

28. Taxation

The Policyholder agrees to pay or allows the Company to deduct from the unit account or any of the benefits payable under this Policy, a sum on account of any tax or other payment which may be imposed by any legislation, order, regulation or otherwise, upon the Company, Policyholder or any other beneficiary, which in the opinion of the Company is necessary and appropriate.

These Policy Document override and supersede all prior communications, arrangements, agreements, and understandings between the Policyholder and Bajaj Allianz Life Insurance Company Limited. In all events, these Policy Document will be the conclusive agreement governing the legal relationship between the parties and no other documents, other than appropriate Endorsements to the Policy signed by an authorized officer of the Company.

The Policy Document and all the Endorsements by the Company, if any, will form an integral part of this contract and will be binding on the parties

Section 39 of the Insurance Act, 1938 – Nomination by Policyholder

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended by The Insurance Laws (Amendment) Act, 2015 dated 20.03.2015. The extant provisions in this regard are as follows:

1. The Member of a life insurance Policy on his own life may nominate a person or persons to whom money secured by the Policy shall be paid in the event of his death.
2. Where the Nominee is a minor, the Member may appoint any person to receive the money secured by the policy in the event of Member's death during the minority of the Nominee. The manner of appointment to be laid down by the Company.
3. Nomination can be made at any time before the maturity of the Policy
4. Nomination may be incorporated in the text of the Policy itself or may be endorsed on the Policy communicated to the Company and can be registered by the Company in the records relating to the Policy.
5. Nomination can be cancelled or changed at any time before Policy matures, by an Endorsement or a further Endorsement or a will as the case may be.
6. A notice in writing of change or cancellation of nomination must be delivered to the Company for the Company to be liable to such Nominee. Otherwise, Company will not be liable if a bona-fide payment is made to the person named in the text of the Policy or in the registered records of the Company.
7. Fee to be paid to the Company for registering change or cancellation of a nomination can be specified by the IRDAI through Regulations.
8. On receipt of notice with fee, the Company should grant a written acknowledgement to the Member of having registered a nomination or cancellation or change thereof.
9. A transfer or assignment made in accordance with section 38 of Insurance Act, 1938, shall automatically cancel the nomination except in case of assignment to the Company or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of Company's or transferee's or assignee's interest in the Policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any Policy of life insurance shall not be affected by the nomination.
11. In case of nomination by Member whose life is insured, if the Nominees die before the Member, the proceeds are payable to Policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case Nominee(s) survive the person whose life is insured, the amount secured by the Policy shall be paid to such survivor(s).
13. Where the Member whose life is insured nominates his/her (a) parents or (b) spouse or (c) children or (d) spouse and children or (e) any of them
The Nominees are beneficially entitled to the amount payable by the Company to the Policyholder unless it is proved that Member could not have conferred such beneficial title on the Nominee having regard to the nature of his title.
14. If Nominee(s) die after the Member but before his share of the amount secured under the Policy is paid, the share of the expired Nominee(s) shall be payable to the heirs or legal representative of the Nominee(s) or holder of succession certificate of such Nominee(s).
15. The provisions of sub-section 13 and 14 above shall apply to all life insurance Policies maturing for payment after the commencement of The Insurance Laws (Amendment) Act, 2015 dated 20.03.2015.
16. If Member dies after maturity but the proceeds and benefit of the Policy has not been paid to him because of his death, his Nominee(s) shall be entitled to the proceeds and benefit of the Policy.
17. The provisions of section 39 of the Insurance Act, 1938, are not applicable to any life insurance Policy to which section 6 of Married Women's Property Act, 1874, applies or has at any time applied except where before or after Insurance Laws (Ordinance) 2014, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the Policy it is mentioned that it is made under section 39 of the Insurance Act, 1938. Where nomination is intended to be made to spouse or children or spouse and children under section 6 of MWP Act, it should be specifically mentioned on the Policy. In such a case only, the provisions of section 39 of Insurance Act, 1938, will not apply.

Annexure BB

Section 45 – Policy shall not be called in question on the ground of mis-statement after three years

Provisions regarding Policy not being called into question in terms of section 45 of the Insurance Act, 1938, as amended by The Insurance Laws (Amendment) Act, 2015 dated 20.03.2015 are as follows:

1. No Policy of life insurance shall be called in question on any ground whatsoever after expiry of three (3) years from (a) the Policy Commencement Date or (b) the Date of Commencement of Risk or (c) the date of latest revival of the Policy or (d) the Date of Commencement of Rider; whichever is later.
2. On the ground of fraud, a Policy of life insurance may be called in question within three (3) years from (a) the Policy Commencement Date or (b) the Date of Commencement of Risk or (c) the date of latest revival of the Policy or (d) the Date of Commencement of Rider; whichever is later.
3. For this, the Company should communicate in writing to the Company or legal representative or Nominee or assignees of Member, as applicable, mentioning the ground and materials on which such decision is based.
4. Fraud means any of the following acts committed by Member or Policyholder or by his agent, with the intent to deceive the Company or to induce the Company to issue the life insurance Policy:
 - a. The suggestion, as a fact of that which is not true and which the Life Assured or Policyholder does not believe to be true;
 - b. The active concealment of a fact by the Life Assured or Policyholder having knowledge or belief of the fact;
 - c. Any other act fitted to deceive; and
 - d. Any such act or omission as the law specifically declares to be fraudulent.
5. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the Member or Policyholder or his agent keeping silence to speak or silence is in itself equivalent to speak.
6. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Member or Policyholder beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the Member, if alive, or beneficiaries.
7. Life insurance Policy can be called in question within three (3) years on the ground that any statement of or suppression of a fact material to expectancy of life of the Member or Policyholder was incorrectly made in the Proposal Form or other documents, basis which Policy was issued or revived or Rider issued. For this, the Company should communicate in writing to the Member or Policyholder or legal representative or Nominee or assignees of Member, as applicable, mentioning the ground and materials on which decision to repudiate the Policy of life insurance is based.
8. In case repudiation is on ground of mis-statement and not on fraud, the premium(s) collected on Policy till the date of repudiation shall be paid to the Member or legal representative or Nominee or assignees of Member, within a period of 90 days from the date of repudiation.
9. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the Company. The onus is on Company to show that if the Company had been aware of the said fact, no life insurance Policy would have been issued to the Member.
10. The Company can call for proof of age at any time if he is entitled to do so and no Policy shall be deemed to be called in question merely because the terms of the Policy are adjusted on subsequent proof of age of Member. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
