Bajaj Allianz ULIP Accidental Permanent Total/Partial Disability Benefit Rider

Part A

FORWARDING LETTER

As per Base Policy

Free Look Condition:

Within fifteen (15) days [thirty (30) days in case this Rider is issued under the provisions of IRDAI Guidelines on Distance Marketing of Insurance Products] of the receipt of this Rider, the Policyholder may, if dissatisfied with any of the terms and conditions for any reason, give the Company a written notice of cancellation along with reasons for the same, and return the Rider Document to the Company, subject to which the Company shall reverse the Rider Premium Charge to the Unit Account after deduction of proportionate Rider Premium Charge for the period of rider cover, expenses incurred on medical examination, if any, and stamp duty charges, if any.

PREAMBLE

The Bajaj Allianz Unit Linked Accidental Permanent Total/Partial Disability Benefit Rider is an additional rider benefit attached with the base Policy. This document should be read along with the base Policy Document and form part of the base Policy Document. The continuance of risk cover under the base Policy is necessary precondition for continuance of cover under this Rider.

Part B

DEFINITIONS & ABBREVIATIONS

In this Policy where the context so admits, the masculine shall include the feminine, the singular shall include the plural and the following expressions shall (unless repugnant to the context) have the following meanings;

- 1) Definitions & Abbreviations
- "Accident" means a sudden unforeseen and involuntary event caused by external and visible means.
- b. "Accidental Permanent Total/Partial Disability" means disability as a result of bodily injury caused by an Accident, and such injury shall within 180 days of its occurrence solely, directly and independently of any other cause, result in the Rider Life Assured's disability.
- "Claimant" means the Policyholder (if different from the Rider Life Assured) or the Nominee or the legal heirs to whom the Rider Benefit will be payable.
- d. "Date of Commencement of Rider" means the date specified in the Schedule (unless the Policyholder is informed otherwise by the Company) from which the Rider Benefit commences under the Rider.
- e. "Rider" means the arrangements established by the Rider Policy Document.
- f. "Rider Premium Charge" means the charge deducted to provide the Rider benefit. For more details, refer to Section 5 and Section 10 below.
- g. "Rider Life Assured" means the person named as the Rider Life Assured in the Schedule whose life is assured under this Rider.
- "Rider Maturity Benefit" means the benefit payable under the Rider on the Rider
 Maturity Date. For more details, refer to Section 4b) below
- i. "Rider Maturity Date" means the date as mentioned in the Schedule
- j. "Rider Sum Assured" means the sum assured as mentioned in the Schedule.
- k. "Rider Surrender Benefit" means the benefit payable if the Rider is surrendered/excluded or terminated. For more details, refer to Section 6 below
- "Rider Term" means the period between the Date of Commencement of Rider and the Rider Maturity Date, as mentioned in the schedule.

Part C

- 2) Rider Description
- a) This Rider is a Unit Linked accidental disability benefit rider attached to the base Policy.
- The Rider provides benefit on occurrence of Accidental Permanent Total/Partial Disability.
- Rider Death Benefit, Rider Maturity Benefit or Rider Surrender Benefit is not available with respect to this Rider.
- d) The Rider does not in any way confer any right whatsoever on the Policyholder or the Rider Life Assured to share in the assets, the profits or surplus of the business of the Company.
- 3) Accidental Permanent Total/Partial Disability Benefit
- On Accidental Permanent Total/Partial Disability to the Rider Life Assured, the Company shall pay the beenfit mentioned in Section 4 below to the Claimant.
- ii) A writtien intimation should reach the Company pregferably within 60 days of occurrence of the Accidental Permanent Total/Partial Disability of the Rider Life
- iii) The above benefit is payable provided the Rider has not been terminated as per Section 10, and is subject to Section 7, Section9, Section12 and Section 17 below.
- Accidental Permanent Partial Disability is defined as a bodily injury that must result in at least one of the following.
- a. Loss of one eye
- b. Loss of one leg
- c. Loss of one arm

- d Loss of one foot
- e. Loss of one hand
- Accidental Permanent Total Disability is defined as a bodily injury that must result in one of the following
- a. Loss of both eyes
- b. Loss of both arms or both hands
- c. Loss of one arm and one leg
- d. Loss of one arm and one foot
- e. Loss of one hand and one foot
- f. Loss of one hand and one leg
- g. Loss of both legs
- h. Loss of both feet
- i. Removal of lower jaw
- vi) If the disability is due to amputation / dismemberment, loss of hand will mean amputation / dismemberment above wrist, loss of arm will mean amputation / dismemberment above elbow, loss of feet will mean amputation / dismemberment above ankle and loss of leg will mean amputation / dismemberment above knee.
- vii) If the disability is not due to amputation/dismemberment, loss will mean loss of usage of limb/s of motor-grade power 0/5, 1/5 or 2/5 only. In permanent total disability, both the limbs should have motor-grade power less than or equal to 2/5
- Loss of one/both eye/s means total loss of vision in that/both eye/s, certified by an ophthalmologist.
- ix) The disability has to be certified by a registered medical practitioner.

The Accidental Permanent Total/Partial Disability Benefit is paid if and only if disability is detected as per above condition.

The Company does not cover any other Accidental Permanent Total/Partial Disability other than that mentioned in Section 3 above.

- 4) Rider Benefits
- a) Accidental Permanent Total/Partial Disability Benefit
- The amount payable in the event of Accidental Permanent Partial disability as a result of an accident within 180 days from the date of an accident shall be 50% of Sum assured under the rider.
- ii) If the Rider Life Assured didn't receive a benefit for Accidental Permanent Partial Disability earlier, the amount payable in the event of Accidental Permanent Total Disability shall be the Rider Sum Assured

Once the above mentioned benefit is taken the rider terminates.

- iii) If the policyholder did receive a benefit for Accidental Permanent Partial Disability before and the time passed from the occurrence of partial disability is less than one year, the amount payable in the event of Accidental Permanent Total Disability benefit shall be 50% of Rider Sum Assured
 - Once the above mentioned benefit is taken the rider terminates
- iv) If the rider life assured did receive a benefit for Accidental Permanent Partial Disability before and the time passed from the occurrence of partial disability is atleast one year, the amount payable in the event of Accidental Permanent Total Disability shall be the Rider Sum Assured.
 - Once the above mentioned benefit is taken the rider terminates
- Once the full benefit has been under the Rider, no further benefit shall be payable for any Accidental Permanent Partial Disability.
- b) Rider Maturity Benefit
 - No Rider Maturity Benefit is payable under the Rider.
- c) Rider Death Benefit
 - No Rider Death Benefit is payable under the Rider.

5) Rider Premium Conditions

The Rider Premium Charge will be deducted from the Fund/s under the base Policy on the Date of Commencement of Rider and on each Monthly Due Date thereafter.

Part D

6) Surrender Benefit

No Rider surrender benefit is payable under the Accidental Permanent Total/Partial Disability Benefit Rider.

7) Reviva

A lapsed Rider can be revived subject to the revival conditions applicable to the base Policy.

- 8) Flexibilities: Option to include/exclude the rider
- a) The Policyholder will have the option to include the Rider under the Policy at the Monthly Anniversary which is the date coinciding with the Date of Commencement of Rider in any month.
- b) The Policyholder will have the option to exclude the rider at any time during the Rider Term. On exclusion the Rider will immediately cease no further Rider Premium Charge as applicable will be deducted. Once this Rider is excluded, it can be added back again anytime subject to underwriting.
- 9) Exclusions

The Rider does not cover any other risk, other than that mentioned in Section 3 and 4 above.

Some of the salient exclusions under the Rider are as given below:

- Disability as a result of the Rider Life Assured committing any breach of law with criminal intent:
- Disability of Rider Life Assured as a result of war, invasion, civil war, rebellion or riot;
- c) Disability as a consequence of the Rider Life Assured being under the influence of alcohol or drugs other than drug prescribed by and taken in accordance with the directions of a registered medical practitioner;
- Disability as a result of the Rider Life Assured taking part in any naval, military or air force operation;
- Disability as a result of the Rider Life Assured participating in or training for any dangerous or hazardous sport or competition or riding or driving in any form of race or competition;
- f) Disability of Rider Life Assured as a result of aviation, gliding or any form of aerial flight other than as a fare paying passenger on a civilian airline plying on regular routes and according to a scheduled timetable;
- Disability of Rider Life Assured as a result of attempted self injury whilst sane or insane.
- 10) Termination/Expiry of Rider Benefit

The Rider shall automatically terminate on the earlier occurrence of either of the following.

- a. If the Rider Life Assured terminates the Rider
- b. On the Policy Anniversary in which the attained age is 65 years.
- c. On maturity of the Rider.
- d. If risk cover under base Policy is discontinued
- e. On receipt of Accidental Permanent Total Disability Benefit

Part E

CHARGES, FUND OPTIONS, PORTFOLIO STRATEGIES, Etc

- 11) Rider Premium Charge
- a) The Rider Premium Charge (as per the Rider Premium Charge mentioned below) depends on the Rider Sum Assured and the attained Age of the Rider Life Assured, both, as on the Date of Commencement of Rider and on each Monthly Due Date thereafter.

b) Rider Premium Charge for all ages is 0.25 per 1000 SA.

Part F

General Conditions

12) Non Forfeiture

All benefits under this rider shall continue if the risk cover under base Policy is continued, subject to Section 10 above.

13) Assignment

Assignment should be in accordance with provisions of section 38 of the Insurance Act 1938 as amended from time to time.

14) Nomination

Nomination should be in accordance with provisions of section 39 of the Insurance Act 1938 as amended from time to time.

15) Fraud, Misrepresentation and forfeiture

Fraud, Misrepresentation and forfeiture would be dealt with in accordance with provisions of section 45 of the Insurance Act 1938 as amended from time to time.

16) Age

Age related conditions are as per the base Policy provisions

17) Payment of claim

If a claim arises under the rider due to an Accidental Permanent Total/Partial Disability, the claim settlement requirements and processes shall be as below.

- a) All notices, applications or notification of claim must be received and approved at the office of the Company authorized to deal with the claim.
- b) No benefit shall be payable until the rider life assured has provided satisfactory proof to the Company of the occurrence of the Accidental Permanent Total Disability or Accidental Permanent Partial Disability. This includes
- A certificate of disability from a registered medical practitioner.
- Any other document that may be relevant in establishing the validity of the claim.
- c) Claim intimation should be received in writing within 60 days of occurrence of the Accident, which is causing total/partial disability of the rider life assured.
- d) In case of any force ma'jeure events (like earth quake, cyclone, flood, etc.), if the Claimant cannot produce any/all documents as stated above, the Company may undertake any investigation and the decide to pay the claim, if the Company is satisfied of the same.

The above mentioned 60 days may be condoned by the Company if it is satisfied as to the genuineness of the reasons for the delay.
