Bajaj Allianz ULIP Waiver of Premium Benefit Rider

Part A

FORWARDING LETTER

As per Base Policy

Free Look Cancellation (FLC): FLC will be as mentioned in the base Policy, but will be applicable from the Date of Commencement of Rider, if different from the Date of Commencement of Risk (of the base Policy).

PREAMBLE

The Bajaj Allianz Unit Linked Waiver of Premium Benefit Rider is an additional rider benefit attached with the base Policy. This document should be read along with the base Policy Document and form part of the base Policy Document. Wherever terms & conditions are not specified in this Rider Document, the terms & conditions of the base policy will apply, to the extent applicable to the Rider. The continuance of risk cover under the base Policy is necessary precondition for continuance of cover under this Rider.

As per Base Policy Schedule or Policy Endorsement (as applicable)

Part B

DEFINITIONS & ABBREVIATIONS

The following terms shall have the meaning assigned to them below. The singular includes the plural and references to the male include the female where the context so permits.

- 1) Definitions & Abbreviations:
 - a. "Accident" means a sudden unforeseen and involuntary event caused by external, visible and violent means
 - b. "Accidental Permanent Total Disability" means disability as a result of bodily injury caused by an accident and such injury shall within 180 days of its occurrence solely, directly and independently of any other cause, result in the disability as defined in Section 4 below and subject to exclusions mentioned in Section 11 below.
 - c. "Claimant" means the Policyholder (if different from the Rider Life Assured) or the Nominee or the legal heirs to whom the Rider Benefit will be payable
 - d. "Critical Illness" means Cancer of Specified severity; First Heart Attack – of specified severity; Open Chest CABG; Kidney Failure requiring regular dialysis; Stroke resulting in permanent symptoms; Major Organ/ bone marrow transplant; Permanent paralysis of limbs; Multiple Sclerosis with persisting symptoms; Aortic Surgery; Primary Pulmonary Hypertension; Alzheimer's Disease, all as defined in Section 5 below and subject to exclusions mentioned in Section 11 below.
 - e. "Date of Commencement of Rider" means the date specified in the Schedule (unless the Policyholder is informed otherwise by the Company) from which the Rider Benefit of the Rider Life Assured commences under the Policy.
 - f. "Goods and Service Tax" ("GST") is charged based on type of policy communication address of Policy Holder. This may change subject to change in rate/state in address of the Policy Holder as on date of adjustment.
 - g. "GST" means Goods and Service Tax.
 - h. "Rider" means the arrangements established by the Rider Policy Document.
 - i. "Rider Benefit" means the benefit payable under the Rider on the happening of the contingent event covered under the Rider. For more details, refer to Section 3 below.
 - j. "Rider Life Assured" means the person named as the Rider Life Assured in the Schedule whose life is assured under this Rider.
 - k. "Rider Maturity Benefit" means the benefit payable under the Rider on the Rider Maturity Date. For more details, refer to Section 3b) below
 - l. "Rider Maturity Date" means the date as mentioned in the Schedule
 - m. "Rider Premium Charge" means the charge deducted to provide the Rider benefit. For more details, refer to Section 6 and Section 13 below.
 - n. "Rider Term" means the period between the Date of Commencement of Rider and the Rider Maturity Date, as mentioned in the schedule.
 - o. "Rider Surrender Benefit" means the benefit payable if the Rider is surrendered/excluded or terminated. For more details, refer to Section 8 below

Part C

- 2) Policy Description
 - a. This Rider is a Unit Linked, life, pure risk premium, waiver of premium benefit rider attached to individual ULIP product.
 - b. The Rider can be taken on the Life assured or on the Policyholder under the base Policy. The events covered with respect to each are given in Section 3 below.
 - c. The Rider provides waiver of future Regular Premium under the Policy on the first occurrence of death (if applicable), first diagnosis of any of the 11 specified Critical Illness or Accidental Permanent Total Disability.
 - d. Rider Maturity Benefit or Rider Surrender Benefit is not available with respect to this Rider.
 - e. The Rider does not in any way confer any right whatsoever on the Policyholder or the Rider Life Assured to share in the assets, the profits or surplus of the business of the Company.

3) Rider Benefit

a) Waiver of Premium Benefit

i) If Rider Life Assured is the Life Assured under the base Policy:

On first occurrence of Accidental Permanent Total Disability or diagnosis of first Critical Illness on the life of the Rider Life Assured, the Company shall pay an amount equivalent to the future Regular Premium at periodical intervals which will be infused in to the Fund/s under the base Policy on corresponding Premium Due Dates under the Policy. The Policy will continue as in-force with all other

benefits.

ii) If Rider Life Assured is the Policyholder under the base Policy:

On first occurrence of death, Accidental Permanent Total Disability or diagnosis of first Critical Illness on the life of the Rider Life Assured, the Company shall pay an amount equivalent to the future Regular Premiums at periodical intervals which will be infused in to the Fund/s under the base Policy on corresponding Premium Due Dates under the Policy. The Policy will continue as in-force with all other benefits.

iii) The above benefit is payable provided the Rider has not been terminated as per Section 12 below, and subject to Section 9, Section 11, Section 14 and Section 19 below.

b) Rider Maturity Benefit

No Rider Maturity Benefit is available under Waiver of Premium Benefit Rider.

c) Rider Death Benefit

i) If the Rider Life Assured is the Life Assured under the base Policy, then, no Rider Death Benefit is available under Waiver of Premium Benefit Rider.

ii) If the Rider Life Assured is the Policyholder under the base Policy, then, the benefit available on death of the Rider Life Assured will be as mentioned in Section 3a) above.

4) Accidental Permanent Total Disability

a) Accidental Permanent Total Disability of the Rider Life Assured which must be permanent and total and must result in at least one of the following:

- (i) Loss of both eyes; (ii) Loss of both arms or both hands; (iii) Loss of one arm and one leg; (iv) Loss of one arm and one foot; (v) Loss of one hand and one foot (vi) Loss of one hand and one leg; (vii) Loss of both legs; (viii) Loss of both feet (ix) Removal of lower jaw

b) If the disability of the Rider Life Assured is due to amputation / dismemberment, loss of hand will mean amputation / dismemberment above wrist, loss of arm will mean amputation / dismemberment above elbow, loss of feet will mean amputation/dismemberment above ankle and loss of leg will mean amputation / dismemberment above knee.

c) If the disability of the Rider Life Assured is not due to amputation/dismemberment, loss will mean loss of usage of both the limbs of motor-grade power 0/5, 1/5 or 2/5 only. In permanent total disability, both the limbs should have motor-grade power less than or equal to 2/5.

d) Loss of both eyes means total loss of vision in both eyes, certified by an ophthalmologist.

e) The disability has to be certified by a registered medical practitioner.

5) Critical Illness

a) The diagnosis of the Critical Illness needs to be confirmed by a registered Medical Practitioner appointed by the Company and has to be supported by acceptable clinical, radiological, histological and laboratory evidence. The Company should be informed of the Critical Illness within 60 days of diagnosis of the Critical Illness. The Rider Life Assured should be alive for a Survival Period of at least 30 days from date of diagnosis of Critical Illness.

The benefit with respect to the critical illness is available on the first diagnosis of any one of the eleven (11) specified critical illnesses mentioned below, after the waiting period of 90 days from the inception or latest revival of the policy.

b) The 11 Critical Illness covered under the Rider are as given below

(1) CANCER OF SPECIFIED SEVERITY

A malignant tumour characterised by the uncontrolled growth & spread of malignant cells with invasion & destruction of normal tissues. This diagnosis must be supported by histological evidence of malignancy. The term cancer includes leukemia, lymphoma and sarcoma.

The following are excluded –

- (i) All tumors which are histologically described as carcinoma in situ, benign, pre-malignant, borderline malignant, low malignant potential, neoplasm of unknown behavior, or non-invasive, including but not limited to: Carcinoma in situ of breasts, Cervical dysplasia CIN-1, CIN - 2 and CIN-3. ; (ii) Any non-melanoma skin carcinoma unless there is evidence of metastases to lymph nodes or beyond; (iii) Malignant melanoma that has not caused invasion beyond the epidermis; (iv) All tumors of the prostate unless histologically classified as having a Gleason score greater than 6 or having progressed to at least clinical TNM classification T2N0M0; (v) All Thyroid cancers histologically classified as T1N0M0 (TNM Classification) or below; (vi) Chronic lymphocytic leukaemia less than RAI stage 3; (vii) Non-invasive papillary cancer of the bladder histologically described as TaN0M0 or of a lesser classification; (viii) All Gastro-Intestinal Stromal Tumors histologically classified as T1N0M0 (TNM Classification) or

(2)	<p>FIRST HEART ATTACK – OF SPECIFIED SEVERITY</p> <p>The first occurrence of heart attack or myocardial infarction which means the death of a portion of the heart muscle as a result of inadequate blood supply to the relevant area. The diagnosis for this will be evidenced by all of the following criteria:</p> <p>(i) a history of typical clinical symptoms consistent with the diagnosis of Acute Myocardial Infarction (for e.g. typical chest pain); (ii) new characteristic electrocardiogram changes; (iii) elevation of infarction specific enzymes, Troponins or other specific biochemical markers.</p> <p>The following are excluded: (a).Other acute Coronary Syndromes (b).Any type of angina pectoris. (c) A rise in cardiac biomarkers or Troponin T or I in absence of overt ischemic heart disease OR following an intra-arterial cardiac procedure.</p>	(10)	<p>specifically excluded.</p> <p>PRIMARY PULMONARY HYPERTENSION</p> <p>An unequivocal diagnosis of Primary (Idiopathic) Pulmonary Hypertension by a Cardiologist or specialist in respiratory medicine with evidence of right ventricular enlargement and the pulmonary artery pressure above 30 mm of Hg on Cardiac Catheterization. There must be permanent irreversible physical impairment to the degree of at least Class IV of the New York Heart Association Classification of cardiac impairment.</p> <p>The NYHA Classification of Cardiac Impairment are as follows:</p> <p>i. Class III: Marked limitation of physical activity. Comfortable at rest, but less than ordinary activity causes symptoms.</p> <p>ii. Class IV: Unable to engage in any physical activity without discomfort. Symptoms may be present even at rest.</p> <p>Pulmonary hypertension associated with lung disease, chronic hypoventilation, pulmonary thromboembolic disease, drugs and toxins, diseases of the left side of the heart, congenital heart disease and any secondary cause are specifically excluded..</p>
(3)	<p>OPEN CHEST CABG</p> <p>The actual undergoing of heart surgery to correct blockage or narrowing in one or more coronary artery(s), by coronary artery bypass grafting done via a sternotomy (cutting through the breast bone) or minimally invasive keyhole coronary artery bypass procedures. The diagnosis must be supported by a coronary angiography and the realization of surgery has to be confirmed by a cardiologist.</p> <p>The following are excluded:</p> <p>i. Angioplasty and/or any other intra-arterial procedures</p>	(11)	<p>ALZHEIMER'S DISEASE</p> <p>Progressive and permanent deterioration of memory and intellectual capacity as evidenced by accepted standardised questionnaires and cerebral imaging.</p> <p>The diagnosis of Alzheimer's disease must be confirmed by a specialised medical practitioner. There must be significant reduction in mental and social functioning requiring the continuous supervision of the life assured. There must also be an inability of the Life Assured to perform (whether aided or unaided) at least three (3) of the following six (6) Activities of Daily Living* for a continuous period of at least three (3) months.</p> <p>Activities of Daily Living are defined as:</p> <p>a) Washing – the ability to wash in the bath or shower (including getting into and out of the bath or shower) or wash satisfactorily by other means;</p> <p>b) Dressing – the ability to put on, take off, secure and unfasten all garments and, as appropriate, any braces, or artificial limbs or other surgical appliances;</p> <p>c) Transferring – the ability to move from a bed to an upright chair or wheelchair and vice versa;</p> <p>d) Toileting – the ability to use the lavatory or otherwise manage bowel and bladder functions so as to maintain a satisfactory level of personal hygiene;</p> <p>e) Feeding – the ability to feed oneself once food has been prepared and made available.</p> <p>f) Mobility - the ability to move from room to room without requiring any physical assistance.</p> <p>The following are excluded: (i) Drug-induced or toxic causes of Parkinsonism; (ii) Any other type of irreversible organic disorder/dementia; (iii) Non-organic disease such as neurosis; and (iv) Alcohol-related brain damage.</p> <p>The Company does not cover any other Accidental Permanent Total Disability or Critical Illnesses under the Rider other than those mentioned in Section 4 and Section 5 above.</p>
(4)	<p>KIDNEY FAILURE REQUIRING REGULAR DIALYSIS</p> <p>End stage renal disease presenting as chronic irreversible failure of both kidneys to function, as a result of which either regular renal dialysis (hemodialysis or peritoneal dialysis) is instituted or renal transplantation is carried out. Diagnosis has to be confirmed by a specialist medical practitioner.</p>		
(5)	<p>STROKE RESULTING IN PERMANENT SYMPTOMS</p> <p>Any cerebrovascular incident producing permanent neurological sequelae. This includes infarction of brain tissue, thrombosis in an intracranial vessel, haemorrhage and embolisation from an extracranial source. Diagnosis has to be confirmed by a specialist medical practitioner and evidenced by typical clinical symptoms as well as typical findings in CT Scan or MRI of the brain. Evidence of permanent neurological deficit lasting for atleast 3 months has to be produced.</p> <p>The following are excluded: (i) Transient ischemic attacks (TIA); (ii) Traumatic injury of the brain; (iii) Vascular disease affecting only the eye or optic nerve or vestibular functions.</p>		
(6)	<p>MAJOR ORGAN /BONE MARROW TRANSPLANT</p> <p>The actual undergoing of a transplant of: (i) One of the following human organs: heart, lung, liver, kidney, pancreas, that resulted from irreversible end-stage failure of the relevant organ, or (ii) Human bone marrow using haematopoietic stem cells The undergoing of a transplant has to be confirmed by a specialist medical practitioner.</p> <p>The following are excluded: (i) Other stem-cell transplants; (ii) Where only islets of langerhans are transplanted.</p>		
(7)	<p>PERMANENT PARALYSIS OF LIMBS</p> <p>Total and irreversible loss of use of two or more limbs as a result of injury or disease of the brain or spinal cord. A specialist medical practitioner must be of the opinion that the paralysis will be permanent with no hope of recovery and must be present for more than 3 months.</p>	6)	<p>Rider Premium Conditions</p> <p>The Rider Premium Charge will be deducted from the Fund/s under the base Policy on the Date of Commencement of Rider and on each Monthly Due Date thereafter.</p>
(8)	<p>MULTIPLE SCLEROSIS WITH PERSISTING SYMPTOMS</p> <p>The unequivocal diagnosis of Definite Multiple Sclerosis confirmed and evidenced by all of the following:</p> <p>i. investigations including typical MRI findings which unequivocally confirm the diagnosis to be multiple sclerosis and</p> <p>ii. there must be current clinical impairment of motor or sensory function, which must have persisted for a continuous period of at least 6 months.</p> <p>Other causes of neurological damage such as SLE is excluded.</p>		<p>Part D</p> <p>As per base Policy</p>
