Bajaj Allianz Family Income Benefit Rider

We work hard and earn to fulfill all our family's needs. We are, to a large extent, dependent on our income to financially secure our families. But, what if an unfortunate event like death, accidental disability or critical illness hampers our income flow?

We understand this concern and present - Bajaj Allianz Family Income Benefit Rider (FIB) which guarantees security of income to your family in case of such unfortunate events. Making sure your family is financially protected always for a worry free life.

Rider Benefits

On first occurrence of death, accidental permanent total disability or first diagnosis of any of the specified 11 critical illness of the Rider Life Assured, 1% of the Rider Sum Assured will be payable monthly for a period of the rider term subject to a minimum of 10 years.

Maturity Benefit

There is no maturity benefit under this rider.

Rider Premium

Rider premium would be collected over and above the base policy premium and it would be based on the age at entry, rider sum assured chosen, rider term and rider premium payment term.

Inclusion / Exclusion of Rider

You will have the option to include the rider only at the inception of the policy. Inclusion of the rider will be subject to underwriting.

The rider can be excluded anytime during the rider term. On exclusion of the rider you will be eligible for surrender value, if rider premium payment term is less than rider term and if two full years premium has been paid in case of rider term less than 10 years and three full years premium is paid in case of rider term greater than or equal to 10 years.

$$\text{Surrender value} = 70\% \times \left(\frac{n-t}{n}\right)^2 \times \text{Total rider premium paid}$$

where, n – rider term

t – elapsed duration in years and fraction thereof from the date of commencement of rider cover

Once this rider is excluded, it cannot be added back again. The rider benefit will immediately cease, and no further rider premium will be collected.

Non-Payment of Premiums

If due premium are not paid during the rider premium paying term, the rider benefit ceases immediately on the expiry of the grace period and no rider benefit will be payable except the surrender value, if any. The rider can be revived based on the conditions as applicable to the base policy.

Free Look Period

Within 15 days [30 days in case this Rider is issued under the provisions of IRDA Guidelines on Distance Marketing of Insurance Products] of the receipt of this Rider, you have the option to review the terms and conditions of the Rider and if you disagree to any of the terms & conditions, you have an option to return the Rider stating the reasons for his objections. You shall be entitled to a refund comprising the Rider Premium (excluding applicable taxes) paid, less the proportionate amount of rider risk premium, for the period the Rider Life Assured was on cover and the expenses incurred by the Company on medical examination, if any and stamp duty charges, if any.

Definitions

- i. Rider Life Assured is the person whose life is assured under this Rider.
- ii. Disability means, disability of the Rider Life Assured as a result of bodily injury caused by an accident (a sudden unforeseen and involuntary event caused by external and visible means) and such injury shall within 180 days of its occurrence solely, directly and independently of any other cause, result in the Rider Life Assured's disability which must be permanent and either total and must result in at least one of the following:
 - Accidental Permanent Total Disability is defined as an event that must result in one of the following:
 - (i) Loss of both eyes; (ii) Loss of both arms or both hands; (iii) Loss of one arm and one leg; (iv) Loss of one arm and one foot; (v) Loss of one hand and one foot (vi) Loss of one hand and one leg; (vii) Loss of both legs; (viii) Loss of both feet; (ix) Removal of lower jaw
 - Loss of both eyes means total loss of vision in both eyes, certified by an ophthalmologist.
 - If the disability is due to amputation/ dismemberment, loss of hand will mean amputation/ dismemberment above wrist, loss of arm will mean amputation/ dismemberment above elbow, loss of feet will mean amputation/dismemberment above ankle and loss of leg will mean amputation/ dismemberment above knee.
 - If the disability is not due to amputation/dismemberment, loss will mean loss of usage of both the limbs of motor-grade power 0/5, 1/5 or 2/5 only. In permanent total disability, both the limbs should have motor-grade power less than or equal to 2/5.

iii. Critical illnesses covered

1. CANCER OF SPECIFIED SEVERITY

A malignant tumour characterised by the uncontrolled growth & spread of malignant cells with invasion & destruction of normal tissues. This diagnosis must be supported by histological evidence of malignancy & confirmed by a pathologist. The term cancer includes leukaemia, lymphoma and sarcoma.

The following are excluded –

(i) Tumours showing the malignant changes of carcinoma in situ & tumours which are histologically described as premalignant or non-invasive, including but not limited to: Carcinoma in situ of breasts, Cervical dysplasia CIN-1, CIN-2 & CIN-3; (ii) Any skin cancer other than invasive malignant melanoma; (iii) All tumours of the prostate unless histologically classified as having a Gleason score greater than 6 or having progressed to at least clinical TNM classification T2N0M0; (iv) Papillary micro - carcinoma of the thyroid less than 1 cm in diameter; (v) Chronic lymphocytic leukaemia less than Rai stage 3; (vi) Microcarcinoma of the bladder; (vii) All tumours in the presence of HIV infection.

2. FIRST HEART ATTACK – OF SPECIFIED SEVERITY

The first occurrence of myocardial infarction which means the death of a portion of the heart muscle as a result of inadequate blood supply to the relevant area. The diagnosis for this will be evidenced by all of the following criteria:

(i) a history of typical clinical symptoms consistent with the diagnosis of Acute Myocardial Infarction (for e.g. typical chest pain); (ii) new characteristic electrocardiogram changes; (iii) elevation of infarction specific enzymes, Troponins or other specific biochemical markers.

The following are excluded: (a) Non-ST-segment elevation myocardial infarction (NSTEMI) with elevation of Troponin I or T; (b) Other acute Coronary Syndromes (c) Any type of angina pectoris.

3. OPEN CHEST CABG

The actual undergoing of open chest surgery for the correction of one or more coronary arteries, which is/are narrowed or blocked, by coronary artery bypass graft (CABG). The diagnosis must be supported by a coronary angiography and the realization of surgery has to be confirmed by a specialist medical practitioner.

Excluded are: (i) Angioplasty and/or any other intra-arterial procedures; (ii) any key-hole or laser surgery.

4. KIDNEY FAILURE REQUIRING REGULAR DIALYSIS

End stage renal disease presenting as chronic irreversible failure of both kidneys to function, as a result of which either regular renal dialysis (haemodialysis or peritoneal dialysis) is instituted or renal transplantation is carried out. Diagnosis has to be confirmed by a specialist medical practitioner.

5. STROKE RESULTING IN PERMANENT SYMPTOMS

Any cerebrovascular incident producing permanent neurological sequelae. This includes infarction of brain tissue, thrombosis in an intracranial vessel, haemorrhage and embolisation from an extracranial source. Diagnosis has to be confirmed by a specialist medical practitioner and evidenced by typical clinical symptoms as well as typical findings in CT Scan or MRI of the brain. Evidence of permanent neurological deficit lasting for at least 3 months has to be produced.

The following are excluded: (i) Transient ischemic attacks (TIA); (ii) Traumatic injury of the brain; (iii) Vascular disease affecting only the eye or optic nerve or vestibular functions.

6. MAJOR ORGAN / BONE MARROW TRANSPLANT

The actual undergoing of a transplant of: (i) One of the following human organs: heart, lung, liver, kidney, pancreas, that resulted from irreversible end-stage failure of the relevant organ, or (ii) Human bone marrow using haematopoietic stem cells. The undergoing of a transplant has to be confirmed by a specialist medical practitioner.

The following are excluded: (i) Other stem-cell transplants; (ii) Where only islets of langerhans are transplanted.

7. PERMANENT PARALYSIS OF LIMBS

Total and irreversible loss of use of two or more limbs as a result of injury or disease of the brain or spinal cord. A specialist medical practitioner must be of the opinion that the paralysis will be permanent with no hope of recovery and must be present for more than 3 months.

8. MULTIPLE SCLEROSIS WITH PERSISTING SYMPTOMS

The definite occurrence of multiple sclerosis. The diagnosis must be supported by all of the following:

- (i) investigations including typical MRI and CSF findings, which unequivocally confirm the diagnosis to be multiple sclerosis
- (ii) there must be current clinical impairment of motor or sensory function, which must have persisted for a continuous period of at least 6 months, and
- (iii) well documented clinical history of exacerbations and remissions of said symptoms or neurological deficits with at least two clinically documented episodes at least one month apart. Other causes of neurological damage such as SLE and HIV are excluded

9. AORTIC SURGERY

The undergoing of surgery to correct any narrowing, dissection, obstruction or aneurysm of the thoracic or abdominal aorta, but not its branches.

The surgery must be considered medically necessary by a recognized consultant cardiologist and must be the most appropriate treatment.

All minimally invasive procedures such as keyhole, catheter, laser, angioplasty or other intra-arterial techniques are excluded.

Congenital narrowing of the aorta and traumatic injury of the aorta are specifically excluded.

10. PRIMARY PULMONARY HYPERTENSION

Means primary pulmonary hypertension associated with right ventricular enlargement established by cardiac catheterisation, resulting in significant permanent physical impairment to the degree of at least Class 3 of the NEW YORK Heart Association Classification of cardiac impairment and resulting in the Life Insured being unable to perform his/her usual occupation. The condition must be documented for at least three consecutive months.

11. ALZHEIMER'S DISEASE

Means the unequivocal diagnosis of Alzheimer's disease made by a recognized consultant neurologist holding an appointment in this capacity at a major hospital and supported by clinical evidence and standardized testing. The diagnosis must confirm permanent failure of brain function resulting in significant cognitive impairment.

Significant cognitive impairment is defined as a deterioration or loss of intellectual capacity to the extent that it results in the requirement for continual supervision.

Alzheimer's disease resulting from the following is excluded: (i) Alcohol or drug abuse; and (ii) Non-organic diseases such as neurosis or psychiatric illness.

Note -

- The benefit with respect to the Critical Illness can be triggered after the waiting period of 90 days from the inception or latest revival of the policy.
- This benefit will be payable on the first diagnosis of any one of the 11 critical illnesses.
- The Family Income Benefit shall be applicable only on confirmation of the diagnosis by a registered Medical Practitioner appointed by the Company or a competent Government Medical Practitioner and is supported by relevant documentary evidences.
- The Company should be informed of the critical illness preferably within 60 days of diagnosis of the critical illness.
- The Rider Life Assured should be alive for at least 30 days from date of diagnosis of Critical Illness for the rider benefit to be payable.

Grace Period

If premiums are not paid by the due date specified, you will be allowed a grace period as applicable to the base policy to pay the due premium.

If the disability of the Rider Life Assured occurs due to accident/critical illness/death during the grace period, the rider benefit shall be payable as if the policy was in force for full Rider Sum Assured after deduction of the outstanding premiums due as on that date.

Exclusions

The FIB rider benefit due to critical illness shall not be paid on Rider Life Assured in the following conditions:

1. Any of the listed Critical Illness conditions where death occurs within 30 days of the diagnosis
2. Any medical condition which first manifests itself within 90 days of the risk commencement date or reinstatement date whichever is later
3. Any Pre-existing medical condition. "Pre-existing medical condition" definition will be as per health regulation
4. Suicide or attempted suicide or intentional self-inflicted injury, by the Rider Life Assured, whether sane or insane
5. Rider Life Assured being under the influence of drugs, alcohol, narcotics or psychotropic substance, not prescribed by a Registered Medical Practitioner
6. War, invasion, hostilities (whether war is declared or not), civil war, rebellion, terrorist activity, revolution or taking part in a riot or civil commotion, strikes or industrial action
7. Participation by the Rider Life Assured in a criminal or unlawful act with criminal intent or committing any breach of law including involvement in any fight or affray
8. Treatment for injury or illness caused by avocations / activities such as hunting, mountaineering, steeple-chasing, professional sports, racing of any kind, scuba diving, aerial sports, activities such as hand-gliding, ballooning, deliberate exposure to exceptional danger
9. Any underwater or subterranean operation or activity. Racing of any kind other than on foot
10. Existence of any sexually Transmitted Disease (STD) and its related complications or Acquired Immune Deficiency Syndrome (AIDS) or the presence of any Human Immuno-deficiency Virus (HIV)
11. Participation by the Rider Life Assured in any flying activity other than as a bona fide passenger (whether paying or not), in a licensed aircraft provided the Rider Life Assured does not, at the time have any duty on board such aircraft.
12. Nuclear reaction, Radioactive, Biological or chemical contamination due to nuclear accident

The FIB rider benefit due to accidental permanent total disability will not be payable in the following situations:

1. Disability as a result of the Rider Life Assured committing any breach of law with criminal intent
2. Disability of Rider Life Assured as a result of war, invasion, civil war, rebellion or riot
3. Disability as a consequence of the Rider Life Assured being under the influence of alcohol or drugs other than drugs prescribed by and taken in accordance with the directions of a registered medical practitioner
4. Disability as a result of the Rider Life Assured taking part in any naval, military or air force operation
5. Disability as a result of the Rider Life Assured participating in or training for any dangerous or hazardous sport or competition or riding or driving in any form of race or competition
6. Disability of Rider Life Assured as a result of aviation, gliding or any form of aerial flight other than as a fare paying passenger on a civilian airline plying on regular routes and according to a scheduled timetable
7. Disability of Rider Life Assured as a result of attempted self-injury whilst sane or insane

Termination

The rider will terminate:

- if rider premium is discontinued
- if the rider is terminated
- on the policy anniversary on which the attained age of the Rider Life Assured is 65 years
- on maturity of the rider
- on termination of the base policy
- on commencement of family income benefit

Assignment: Section 38 of the Insurance Act, 1938

Assignment should be in accordance with provisions of sec 38 of the Insurance Act 1938 as amended from time to time.

Nomination: Section 39 of the Insurance Act, 1938

Nomination should be in accordance with provisions of sec 39 of the Insurance Act 1938 as amended from time to time.

Prohibition of Rebate: Section 41 of the Insurance Act, 1938

“No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take out or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectuses or tables of the insurer.

Any person making default in complying with the provisions of this section shall be punishable with a fine which may extend upto ten lakh rupees.”

Fraud, Misrepresentation & Forfeiture- Section 45 of the Insurance Act, 1938

Fraud, Misrepresentation and forfeiture would be dealt with in accordance with provisions of Sec 45 of the Insurance Act 1938 as amended from time to time.
