DEFINITIONS & ABBREVIATIONS

This Policy is issued on the basis of the information given and declaration made by the Policyholder in the Proposal Form, which is incorporated herein and forms the basis of this Policy. The following terms shall have the meaning assigned to them below. The singular includes the plural and references to the male include the female where the context so permits.

- 1) Definitions & Abbreviations:
 - a. "Age" means age as at last birthday.
 - b. "Annualised Premium" means the total amount of Regular Premiums payable in a Policy Year. In this calculation any extra premium, Rider Premium or applicable taxes are excluded.
 - c. "Business Day" is the common working day of the Corporate Office of the Company.
 - d. "Claimant" means the Life Assured (if alive) or Policyholder (if different from the Life Assured) or the assignee or the Nominee or the legal heirs of Policyholder/Nominee(s) to whom the Policy Benefit will be payable.
 - e. "Company" refers to BAJAJ ALLIANZ LIFE INSURANCE COMPANY LIMITED.
 - f. "Date of Commencement of Risk" means the date specified in the Schedule (unless the Policyholder is informed otherwise by the Company) from which the risk cover of the Life Assured commences under the Policy.
 - g. "Death Benefit" is the benefit payable on the death of the Life Assured as mentioned in the Schedule. The details are as given in Section 4a) below.
 - h. "Financial Year" means the year starting from 1st April of a year and ending on 31st March of the next year.
 - i. "Goods and Service Tax" is charged based on type of policy communication address of Policy Holder. This may change subject to change in rate/state in address of the Policy Holder as on date of adjustment.
 - j. "Grace Period" means a period of fifteen (15) days for a monthly Premium Payment Frequency and thirty (30) days for other than monthly Premium Payment Frequency, from the due date of the Regular Premium payment.
 - k. "GST" means Goods and Service Tax
 - l. "Guaranteed Death Benefit" is 105% of the sum of all Regular Premiums paid as on the date of death of the Life Assured. In this calculation any extra premium, Rider Premium or applicable taxes are excluded.
 - m. "Guaranteed Monthly Income (GMI)" is an amount as mentioned in the Schedule which is payable every month starting from the end of PPT, till the end of the policy term, subject to Life Assured being alive.
 - n. "Survival Benefit" means the benefit payable on survival of the Life Assured till expiry of Premium Paying Term and shall be paid as per section 4 (b) below.
 - o. "IRDAI" means the Insurance Regulatory and Development Authority of India.
 - p. "Life Assured" means the person named as the Life Assured in the Schedule whose life is assured under this Policy.
 - q. "Maturity Benefit" is the benefit payable on the Maturity Date. The details are as given in Section 4c) below.
 - r. "Maturity Date" means the date specified in the Schedule on which the Maturity Benefit as per Section 4c) below shall become payable to the Policyholder.
"Nominee" means the person who has been nominated in writing to the Company by the Policyholder, who is entitled to receive the Death Benefits under the Policy as mentioned in Section 4a) below.
 - s. "Paid up GMI" is Paid-up Sum Assured / 144 which is payable every month starting from the end of PPT as long as the Life Assured is alive, till the end of the Policy Term.
 - t. "Paid up Sum Assured on Death" is the reduced value of the Sum Assured on Death arrived at by multiplying the Sum Assured on Death with the proportion of the number of Regular Premiums paid to the total number of Regular Premiums payable under the Policy.
 - u. "Paid up Sum Assured" is the reduced value of the Sum Assured arrived at by multiplying the Sum Assured with the proportion of the number of Regular Premiums paid to the total number of Regular Premiums payable under the Policy.
 - v. "Paid-up Survival Benefit" means the benefit payable on survival of the Life Assured till expiry of Premium Paying Term in a Paid Up Policy and shall be paid as per section 4b) below.

- w. "Policy" means the arrangements established by the Policy Document.
- x. "Policy Anniversary" means the date corresponding numerically with the Policy Commencement Date in each subsequent year during the Policy Term.
- y. "Policy Commencement Date" means the date of commencement of the Policy as specified in the Schedule.
- z. "Policy Document" means this Policy wording and that of the Additional Rider Benefits, if any, the Schedule (which is attached to and forms part of this Policy and includes any Annexure or endorsement to it and, if more than one, then, the latest in time) and the Proposal Form.
- aa. "Policyholder" means the adult person named in the Schedule who has concluded the Policy with the Company.
- bb. "Policy Term" means the period between the Policy Commencement Date and the Maturity Date, as specified in the Schedule.
- cc. "Policy Year" means the year commencing on the Policy Commencement Date or a Policy Anniversary thereof.
- dd. "Premium Payment Frequency" is a regular time interval as specified in the Schedule, at which the Regular Premium is payable during the Premium Paying Term.
- ee. "Premium Paying Term" means the period specified in the Schedule during which the Regular Premium is payable.
- ff. "Proposal Form" means the Policyholder's statements in the proposal for this Policy submitted by or on behalf of the Policyholder along with any other information or documentation provided to the Company prior to inception.
- gg. "Regular Premium" means the amount exclusive of applicable taxes, if any, payable by the Policyholder at regular intervals during the Premium Paying Term, in amount and at the Premium Payment Frequency, both, as specified in the Schedule. The Regular Premium includes any Rider Premium, and any extra premium (which will be informed to you, if applicable).
- hh. "Sum Assured" is the amount as specified in the Schedule under the Policy.
- ii. "Sum Assured on Death" is the amount as specified in the Schedule under the Policy and is the higher of:
 - (i) 10 times the Annualised Premium or (ii) Sum Assured
- jj. "Surrender Benefit" means the benefit, if any, payable on the surrender of the Policy. The details are as given in Section 8 below.
- kk. "Vested Bonus" is the amount of compound reversionary bonus already attached with the Policy, based on the rates of compound reversionary bonus declared by the Company in the past for this plan at the end of each Financial Year.

Part C

- 2) Policy Description
 - a) This Policy is a non-linked, participating, limited premium payment, monthly income endowment plan.
The plan provides Death Benefit (as per the Variant chosen), Survival Benefit as a monthly income, Maturity Benefit, Surrender Benefit, compound reversionary bonus and terminal bonus, if any.
 - b) The Policy enables the Policyholder to receive the Bonus, in the manner, amount and timing as declared by the Company, as per the relevant IRDAI Regulations, and does not in any way confer any right whatsoever on the Policyholder or the Life Assured to otherwise share in the assets, the profits or surplus of the business of the Company.
- 3) Premium
 - a) Regular Premium, including applicable taxes, is payable in full on the premium due dates specified in the Schedule or within the Grace Period allowed, during the Premium Paying Term.
 - b) The Company does not have any obligation to issue a notice that Regular Premium is due or for the amount that is due.
 - c) The Company will not accept any amount less than Regular Premium along with applicable taxes, if any, due as the Regular Premium.
 - d) Where the Regular Premium along with applicable taxes, if any, in full has not been paid even within the Grace Period, the Policy shall be subject to the "Non-payment of Premium and Forfeiture" condition(s) as per Section 6 below.
- 4) Policy Benefits
 - a) Death Benefit
 - i) On the death of the Life Assured during the Policy Term and before the Maturity Date, subject to Section 6, Section 7, Section 8, Section 11 and

- Section 22 below, provided the Policy has not been terminated per Section 15 below, the Company shall pay the following Death Benefit to the Claimant.
- (1) If the Policy is in-force, and all Regular Premiums are paid up-to-date, the Death Benefit payable is the higher of:
- (a) Sum Assured on Death Plus Vested Bonus Plus terminal bonus, if any, OR
- (b) 105% of the total premiums* paid
- (2) If the Policy is paid-up, as per Section 6 below, the Death Benefit payable is the higher of:
- (a) Paid-up Sum Assured on Death Plus Vested Bonus Plus terminal bonus, if any, OR
- (b) 105% of the total premiums* paid
- (3) If the Policy is lapsed as on the date of death [as per Section 6 below], no Death Benefit shall be payable, irrespective of the Variant.
- *The total premium is exclusive of extra premium, rider premium and GST.
- ii) The payment of Death Benefit shall be as per the Variant chosen at inception
- (1) Variant "Income":
- (a) Under this Variant, for inforce policies the amount of Death Benefit minus Vested Bonus and terminal bonus, if any, will be paid as a monthly income to the Claimant in 144 equated monthly installments (over the next 12 years), starting from date of death .
- (b) The Vested Bonus Plus terminal bonus, if any, shall be payable as a lump-sum on acceptance of claim for Death Benefit by the Company.
- (c) GMI/ Paid-up GMI paid during the period from the date of death to the date of intimation will be recovered from the monthly income/s.
- (d) All risk cover under the Policy will cease on the date of death and no future bonus will be attached to the Policy. The Policy will terminate on payment of all due monthly incomes.
- The Claimant will not have the option of taking the monthly incomes in lump-sum.
- (e) Under this Variant, for paid up policies the amount of paid-up death benefit minus vested bonus, if any) will be paid as a monthly income to the Claimant in 144 equated monthly installments (over the next 12 years), starting from the date of death. If the monthly income is less than ₹ 400 per month, then, the benefit will be paid annually, which will be equal to paid-up Sum Assured in 12 yearly installments over the next 12 years, starting from the date of death
- (2) Variant "Assure":
- (a) Under the Variant, the amount of Death Benefit will be paid as a lump-sum.
- (b) GMI /Paid up GMI paid during the period from the date of death to the date of intimation will be recovered from the Death Benefit.
- (c) The Policy will terminate on the date of death of the Life Assured.
- b) Survival Benefit:
- Irrespective of the Variant chosen in the Policy, provided the Policy has not been terminated as per Section 15 below or the Death Benefit has not been accepted under the Policy, on the survival of the Life Assured to the end of the Premium Paying Term (PPT),
- i) If the Policy is in-force, and all Regular Premiums are paid up-to-date, the GMI shall be payable at the end of each month as long as the Life Assured is alive, till the end of the Policy Term. The first installment of GMI will start at the end of Premium Paying Term (PPT).
- ii) If the Policy is paid-up, as per Section 6 below,
- (1) Paid-up GMI shall be payable at the end of each month as long as the Life Assured is alive, till the end of the Policy Term. The first installment of Survival Benefit will start at the end of Premium Paying Term (PPT).
- (2) If the Paid-up GMI is less than ₹ 400 per month, then, the benefit will be paid annually, which will be equal to paid-up Paid-up Sum Assured in 12 yearly installments over the next 12 years.
- iii) If death of the Life Assured happens during the payment period of the GMI/ Paid-up GMI, the benefit will be stopped immediately. Any GMI/ Paid-up GMI paid during the period from the date of death to the date of intimation will be recovered from the benefit payable on death, as mentioned in Sub-Section 4)a)ii)(1)c) and Sub-Section 4)a)ii)(2)(b) above.
- c) Maturity Benefit:
- i) If the Policy is in-force at the Maturity Date and the Life Assured is alive, Vested Bonus Plus terminal bonus, if any, shall be payable as the Maturity Benefit.
- ii) If the Policy is paid up at the Maturity Date and the Life Assured is alive, Vested Bonus, if any, shall be payable as the Maturity Benefit.
- iii) Additionally, if applicable, any shortfall in the total of the all the Survival Benefits & Maturity Benefit from 100.1% of the total premium* paid under the Policy will also be paid.
- *The total premium is exclusive of extra premium, rider premium and GST.
- iv) The policy will terminate on the Maturity Date.
- d) Bonus
- The Company will carry out annual valuation (as per the applicable IRDAI regulations) at the end of each Financial Year and may declare following bonuses for the participating policies.
- i) Compound Reversionary Bonus: This is a regular bonus rate expressed as a percentage of the Sum Assured and the Vested Bonus under the Policy. This rate will be applied to the Sum Assured and the Vested Bonus under the Policy to determine the amount of reversionary bonus to be added to the Policy at the end of that Financial Year. The Compound Reversionary Bonus is added to the Policy at the end of that Financial Year provided all the due Premiums under the Policy are paid up to date.
- ii) Terminal Bonus: If the Policy has completed ten (10) Policy Years and all due premiums have been paid, the Company shall pay a Terminal Bonus, as declared, as a percentage of the Sum Assured. Such terminal bonus is payable as part of the Death Benefit or the Maturity Benefit.
- iii) Interim Bonus: In the event of a death claim or maturity of the policy part way through a financial year or before the valuation result is declared, an interim bonus shall be payable, as decided by the Company at the previous valuation date.
- iv) The Compound Reversionary Bonus, Interim Bonus and Terminal Bonus may vary with the policy term chosen by the policyholder.

5) Free Look Period

Within 15 days [thirty (30) days in case this Policy is issued under the provisions of IRDAI Guidelines on Distance Marketing of Insurance Products] of the receipt of this Policy, the Policyholder has an option to review the terms and conditions of the Policy and if the Policyholder disagrees to any of the terms & conditions, he has an option to return the Policy stating the reasons for his objections. The Policyholder shall be entitled to a refund comprising of all the Regular Premiums (excluding applicable taxes) paid, less the proportionate amount of risk premium & additional rider benefit premium, if any, for the period the Life Assured was provided cover and the expenses incurred by the Company on account of medical examination and stamp duty.

6) Non payment of Premium , Paid up benefits and Forfeiture

- a) If at least two (2) full years' Regular Premiums are not paid under a Policy with Premium Paying Term less than ten (10) years OR three (3) full years' Regular Premiums are not paid under a Policy with Premium Paying Term ten (10) years & above, the Policy will immediately & automatically lapse at the expiry of the Grace Period, and no benefit will be payable under the Policy.
- b) If at least two (2) full years' Regular Premiums have been paid under a Policy with Premium Paying Term less than ten (10) years OR three (3) full years' Regular Premiums have been paid under a Policy with Premium Paying Term ten (10) years & above, then, the Policy will be, immediately & automatically, converted to a Paid-up Policy at the expiry of the Grace Period.
- c) The Policyholder may revive a lapsed/Paid up Policy during the revival period of two (2) years from the due date of first unpaid Regular Premium, subject to the condition mentioned in section 7 below.

7) Revival

A Policy, which has lapsed or has become Paid up for non-payment of Regular Premium, may be revived, subject to the following conditions;

- a) The application for revival is made within two (2) years from the due date of the first unpaid Regular Premium.
- b) The arrears of Regular Premiums together with interest, at such rate as the Company may decide from time to time along with applicable taxes are paid. The current applicable revival interest is 10.0% p.a. compounded half-yearly;
- c) The Policyholder furnishes, at his/her own expense, satisfactory evidence of health of the Life Assured and continuity of insurability;
- d) The revival of the Policy may be on terms different from those applicable to the Policy before it lapsed/became paid-up, based on prevailing board approved

- underwriting guidelines.
- e) The revival will take effect only on it being specifically communicated by the Company to the Policyholder.
 - f) The Company may revive or refuse to revive the Policy, based on the prevailing board approved underwriting guidelines. If the Policy is refused revival based on the board approved underwriting guidelines, the Company will refund the amount deposited for the purposes of revival of the Policy.
 - g) On revival, the Sum Assured and Sum Assured on Death under the Policy which prevailed before the date of latest lapse/Paid up will be reinstated. All Compound Reversionary Bonus, if any, due during the lapse/Paid up period will be added / attached to the Policy. Any difference between the Survival Benefits payable and the Paid-up Survival Benefits will be paid as a lump-sum on the date of revival
 - 8) Surrender Benefit
 - i) The Policy can be surrendered by the Policyholder at any time, provided at least two (2) full years' Regular Premiums have been paid for Premium Paying Term less than 10 years or at least three (3) full years' Regular Premiums have been paid for Premium Paying Term of 10 or more years.
 - ii) The surrender value payable will be the higher of the guaranteed surrender value (GSV) or the special surrender value (SSV).
 - iii) The policy will terminate on payment of Surrender Benefit.
 - iv) The GSV is the sum of GSV1 and GSV2.
 - v) GSV1 is obtained by multiplying GSV1 factor (as given in the table below) with total premiums* paid less Guaranteed Monthly Income paid till date.

Policy Surrender Year	GSV1 = Proportion of the total premiums* paid till date
2 and 3	30%
4 to 10	50%
11 to 15	55%
16 & above	60%

- *The total premium is exclusive of extra premium, rider premium and GST.
- vi) GSV2 is obtained by multiplying GSV2 factor (given in Annexure 1) with Vested Bonuses.
 - vii) GSV1 & GSV2 factors are guaranteed.
 - viii) The SSV is the sum of the amount of SSV1 and SSV2.
 - ix) If Surrender happens during Premium Paying Term for a Paid up Policy or an in-force Policy, the SSV1 will be applied on the Paid up sum assured on death plus the Vested Bonus and the SSV2 will be applied on the Paid up sum assured plus the Vested Bonus.
 - x) If Surrender happens after Premium Paying Term:
 - a. For a fully Paid up Policy (where all the due Regular Premiums have been paid in full till the end of Premium Paying Term), the SSV1 will be applied on the Sum Assured on Death plus the Vested Bonus and the SSV2 will be applied on the Sum Assured less Survival Benefits paid till date plus the Vested Bonus.
 - b. For a paid up Policy, the SSV1 will be applied on the Paid up Sum Assured on Death plus the Vested Bonus and the SSV2 will be applied on the Paid up Sum Assured less Paid up Survival Benefit paid till date plus the Vested Bonus.
 - xi) The SSV1 and SSV2 factors as indicated in Annexure 2 are not guaranteed and company will review these factors from time to time, subject to the prior approval of IRDAI.
 - 9) Flexibilities
 - Alteration of Premium Payment Frequency

The Premium Payment Frequency may be changed only at Policy Anniversary during the Premium Paying Term, subject to the availability the Premium Payment Frequency and subject to the prevailing minimum Regular Premium allowed with respect to each Premium Payment Frequency under the plan. Monthly Premium Payment Frequency is allowed only under auto-debit process (auto-debit process as allowed by RBI to financial institutions).
 - 10) Policy Loans

Policy loan will not be available under the product.

- General Conditions
- 11) Suicide Exclusions

If the Life Assured commits suicide whether sane or insane, within one (1) year from the Date of Commencement of Risk or the date of the latest revival of the Policy, the Company's liability shall be limited to the extent of the amount mentioned below. If the death due to suicide is within one (1) year

 - From the Date of Commencement of Risk, the amount payable will be 80% of the Regular Premiums paid OR
 - From the date of the latest revival, the amount payable will be the higher of 80% of the Regular Premiums paid and Surrender Benefit as on the date of death.
 - 12) Age Proof
 - a) The Premium payable under the Policy is calculated on the basis of the Life Assured's Age and gender as declared in the Proposal Form. If the Life Assured's Age has not been admitted by the Company, the Policyholder shall furnish such proof of the Life Assured's Age as is acceptable to the Company and have the Age admitted.
 - b) If the Age so admitted (the "correct Age") is found to be different from the Age declared in the Proposal Form, then, without prejudice to the Company's other rights and remedies including those under the Insurance Act 1938, the following actions shall be taken:

Annexure AA

Section 38 of Insurance Act, 1938, as amended from time to time – Assignment and Transfer of Insurance Policies

Assignment or transfer of a Policy should be in accordance with section 38 of the Insurance Act, 1938, as amended by The Insurance Laws (Amendment) Act, 2015 dated 20.03.2015. The extant provisions in this regard are as follows:

1. This Policy may be transferred / assigned, wholly or in part, with or without consideration.
2. An assignment may be effected in a Policy by an endorsement upon the Policy itself or by a separate instrument under notice to the Company.
3. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
4. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
5. The transfer of assignment shall not be operative as against the Company until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy thereof certified to be correct by both transferor and transferee or their duly authorized agents have been delivered to the Company.
6. Fee to be paid for assignment or transfer can be specified by the IRDAI through Regulations.
7. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the Company of duly receiving the notice.
8. If the Company maintains one or more places of business, such notices shall be delivered only at the place where the Policy is being serviced.
9. The Company may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is (a) not bona-fide or (b) not in the interest of the Policyholder / Life Assured or (c) not in public interest or (d) is for the purpose of trading of the Policy.
10. Before refusing to act upon endorsement, the Company should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of Policyholder giving a notice of transfer or assignment.
11. In case of refusal to act upon the endorsement by the Company, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Company.
12. The priority of claims of persons interested in the Policy would depend on the date on which the notices of assignment or transfer is delivered to the Company; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to IRDAI.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
 - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
 - b. where the transfer or assignment is made upon condition that
 - i. the proceeds under the Policy shall become payable to Policyholder or Nominee(s) in the event of assignee or transferee dying before the Life Assured OR
 - ii. the Life Assured surviving the Policy Term.Such conditional assignee will not be entitled to obtain a loan on Policy or surrender the Policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.
14. In other cases, the Company shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
 - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
 - b. may institute any proceedings in relation to the Policy
 - c. obtain loan under the Policy or surrender the Policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of the Policy under an assignment or transfer effected before commencement of The Insurance Laws (Amendment) Act, 2015 shall not be affected by this section.

Annexure BB

Section 39 of the Insurance Act, 1938, as amended from time to time – Nomination by Policyholder

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938, as amended by The Insurance Laws (Amendment) Act, 2015 dated 20.03.2015. The extant provisions in this regard are as follows:

1. The Policyholder of a life insurance Policy on his own life may nominate a person or persons to whom money secured by the Policy shall be paid in the event of his death.
2. Where the Nominee is a minor, the Policyholder may appoint any person to receive the money secured by the policy in the event of Policyholder's death during the minority of the Nominee. The manner of appointment to be laid down by the Company.
3. Nomination can be made at any time before the maturity of the Policy.
4. Nomination may be incorporated in the text of the Policy itself or may be endorsed on the Policy communicated to the Company and can be registered by the Company in the records relating to the Policy.
5. Nomination can be cancelled or changed at any time before Policy matures, by an endorsement or a further endorsement or a will as the case may be.
6. A notice in writing of change or cancellation of nomination must be delivered to the Company for the Company to be liable to such Nominee. Otherwise, Company will not be liable if a bona-fide payment is made to the person named in the text of the Policy or in the registered records of the Company.
7. Fee to be paid to the Company for registering change or cancellation of a nomination can be specified by the IRDAI through Regulations.
8. On receipt of notice with fee, the Company should grant a written acknowledgement to the Policyholder of having registered a nomination or cancellation or change thereof.
9. A transfer or assignment made in accordance with section 38 of Insurance Act, 1938, as amended from time to time, shall automatically cancel the nomination except in case of assignment to the Company or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of Company's or transferee's or assignee's interest in the Policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any Policy of life insurance shall not be affected by the nomination.
11. In case of nomination by Policyholder whose life is insured, if the Nominees die before the Policyholder, the proceeds are payable to Policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case Nominee(s) survive the person whose life is insured, the amount secured by the Policy shall be paid to such survivor(s).
13. Where the Policyholder whose life is insured nominates his/her (a) parents or (b) spouse or (c) children or (d) spouse and children or (e) any of them, the Nominees are beneficially entitled to the amount payable by the Company to the Policyholder unless it is proved that Policyholder could not have conferred such beneficial title on the Nominee having regard to the nature of his title.
14. If Nominee(s) die after the Policyholder but before his share of the amount secured under the Policy is paid, the share of the expired Nominee(s) shall be payable to the heirs or legal representative of the Nominee(s) or holder of succession certificate of such Nominee(s).
15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance Policies maturing for payment after the commencement of The Insurance Laws (Amendment) Act, 2015 (i.e 20.03.2015).
16. If Policyholder dies after maturity but the proceeds and benefit of the Policy has not been paid to him because of his death, his Nominee(s) shall be entitled to the proceeds and benefit of the Policy.
17. The provisions of section 39 of the Insurance Act, 1938, as amended from time to time, are not applicable to any life insurance Policy to which section 6 of Married Women's Property Act, 1874, applies or has at any time applied except where before or after The Insurance Laws (Amendment) Act, 2015, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the Policy it is mentioned that it is made under section 39 of the Insurance Act, 1938, as amended from time to time. Where nomination is intended to be made to spouse or children or spouse and children under section 6 of MWPA, it should be specifically mentioned on the Policy. In such a case only, the provisions of section 39 of Insurance Act, 1938, as amended from time to time, will not apply.

Annexure CC

Section 45 of the Insurance Act, 1938, as amended from time to time – Policy shall not be called in question on the ground of mis-statement after three years.

Provisions regarding Policy not being called into question in terms of section 45 of the Insurance Act, 1938, as amended by The Insurance Laws (Amendment) Act, 2015 dated 20.03.2015 are as follows:

1. No Policy of life insurance shall be called in question on any ground whatsoever after expiry of three (3) years from (a) the Policy Commencement Date or (b) the Date of Commencement of Risk or (c) the date of latest revival of the Policy or (d) the Date of Commencement of Rider; whichever is later.
2. On the ground of fraud, a Policy of life insurance may be called in question within three (3) years from (a) the Policy Commencement Date or (b) the Date of Commencement of Risk or (c) the date of latest revival of the Policy or (d) the Date of Commencement of Rider; whichever is later.

For this, the Company should communicate in writing to the Company or legal representative or Nominee or assignees of Policyholder, as applicable, mentioning the ground and materials on which such decision is based.
3. Fraud means any of the following acts committed by Life Assured or Policyholder or by his agent, with the intent to deceive the Company or to induce the Company to issue the life insurance Policy:
 - a. The suggestion, as a fact of that which is not true and which the Life Assured or Policyholder does not believe to be true;
 - b. The active concealment of a fact by the Life Assured or Policyholder having knowledge or belief of the fact;
 - c. Any other act fitted to deceive; and
 - d. Any such act or omission as the law specifically declares to be fraudulent.
4. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the Life Assured or Policyholder or his agent keeping silence to speak or silence is in itself equivalent to speak.
5. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Life Assured or Policyholder / Beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the Policyholder, if alive, or beneficiaries.
6. Life insurance Policy can be called in question within three (3) years on the ground that any statement or suppression of a fact material to expectancy of life of the Life Assured or Policyholder was incorrectly made in the Proposal Form or other documents, basis which Policy was issued or revived or Rider issued. For this, the Company should communicate in writing to the Life Assured or Policyholder or legal representative or Nominee or assignees of Policyholder, as applicable, mentioning the ground and materials on which decision to repudiate the Policy of life insurance is based.
7. In case repudiation is on ground of mis-statement and not on fraud, the premium(s) collected on Policy till the date of repudiation shall be paid to the Policyholder or legal representative or Nominee or assignees of Policyholder, within a period of 90 days from the date of repudiation.
8. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the Company. The onus is on Company to show that if the Company had been aware of the said fact, no life insurance Policy would have been issued to the Policyholder.
9. The Company can call for proof of age at any time if he is entitled to do so and no Policy shall be deemed to be called in question merely because the terms of the Policy are adjusted on subsequent proof of age of Life Assured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
